ASSIST had additional outcomes and services it provided but chose to only present the ones listed in order to keep the report brief, and the numbers achieving the goals for the other indicators were small.

The agency has also had a busy year when it comes COVID-19 CARES Act activities. Our agency's goal with the CSBG CARES Act funding was to support individuals and families with regard to the impact they were affected by COVID-19. This is being accomplished by assisting families in remaining in their homes with rental/mortgage and/or utility assistance up to a \$6,000 limit per household. The agency received this funding in the middle of 2020 with the following results:


Received Mortgage Assistance to avoid foreclosure

Received Utility Assistance to avoid being disconnected


As you can see, the ASSIST Agency is touching lives and making a difference. The CSBG CARES Act funding grant runs from June 1, 2020 through September 30, 2022, or until the money runs out.


The agency received a positive Audit Report for the year 2020 with no "findings" being reported. The breakdown of the various sources of grant-based income is illustrated in the following graph.



CSBG was the main funding source at 47.8% followed by the Summer Food and Recreation Program at 17.7%. The FEMA Emergency Food & Shelter Program was next at 7.4%, then the Acadia Parish Elderly Program at 4.0%, Emergency Solutions Grant – Homeless Prevention & Rapid-Rehousing Program (ESG HPRP) 3.8%, Other 3.2%, HUD Housing Counseling 0.9%, UWSWLA 0.8%, UWA 0.4%, and IRS/EITC Tax Program 0.4%.
